**Name of Project : Development and Improvement of Indonesian Aids to Navigation Project**

1. The Government of the Republic of Indonesia has received a loan from the Economic Development Cooperation Fund (EDCF) of The Republic of Korea towards the cost of the Development and Improvement of Indonesian Aids to Navigation Project (hereinafter "AtoN Project") and intends to apply part of the proceeds for the estimated cost for consultancy services is US\$ 7,214,00.
2. The main Work Scope of the project ;
  - A. Basic and Detailed Design / Preparation of Bidding Documents.
  - B. Contractor Selection (Bidding, Bid Evaluation, Contract Negotiation and Contract Signing).
  - C. Supervision on project implementation.
  - D. Training.
3. The period of these services is 34 (Thirty four) months with estimated input of 711 MM (Man Month) of the international and national experts.
4. The AtoN Project consists of architecture part (a) and ICT part (b,c): (a) AtoN Structure Construction (Lighthouse tower: 8 Sites, Light beacon: 95 Sites) , (b) Electrical and Optical System, (c) AIS/RMCS (AISs for 103 sites, A centralized type of RMCS)
5. DGST (The Directorate General of Sea Transportation), as the employer of the Consultant (the Employer), now invites eligible consulting organizations **(limited to Korean Companies in Joint Operation with Indonesian Companies in which nationals of Korea hold more than 50% of shares)** to indicate their interest in providing the services. Interested consultant should provide information demonstrating that they have the required qualification and relevant experience to perform the services, i.e. firm's profile (including description of similar projects, name of client, type of services provided and brief description of the services, name and location of projects, period of contract, starting date and completion date). The shortlisting criteria are: firms' qualification and relevant experience in related field of services to be provided during last ten years. Experience in similar climate and geography will be preferred.
6. Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of shortlisting, the qualification of sub-consultant will not be considered in the EOI evaluation. And form of association, joint venture will not be permitted to be modified after submission of REOI without prior approval of the Employer. A consultant will be selected in accordance with Quality and Cost Based Selection (QCBS) set out in the Consultant Guidelines.
