

INVITATION TO BID



- The Royal Government of the Kingdom of Cambodia has received a loan from the Export-Import Bank
 of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea
 in the amount in Korean Won not exceeding the equivalent of Thirty Six Million Nine Hundred Thousand US
 Dollars (USS 36,900,000) toward the cost of the National Road No.3 Rehabilitation Project Phase II, and
 intends to apply a portion of the proceeds of this loan to payments under the contract for which this Invitation for
 Bid is issued.
- The Ministry of Public Works and Transport (MPWT) of the Kingdom of Cambodia, hereinafter referred to as "the Employer" invites sealed bids from eligible Korea General contractors for the construction and completion of;

Rehabilitation of approx. 137.5 Km of National Road No.3 from Phnorn Penh to Kampot and reconstruction of Bridges and drainage box and pipe culverts.

The works to be carried out in the project site generally comprise the following;

a) Rehabilitation of existing road, generally on the same alignment by widening the earthworks and construction of new pavement with subbase, aggregate basecourse and bituminous surface treatment. On the some part of the road in urban area and bridge pavement will be paved by using Asphalt Concrete.

b) Raising of the new pavement grade in area subject to frequently flooded areas

c) Construction of drainage box/pipe culverts

d) Soil investigations for bridge foundation and construction of new bridges

e) Improvement of side drainage and slope protection

f) Traffic safety features

g) Road signs and road marking

- h) Environment mitigation measures and miscellaneous works
- 3. The Invitation to bid is open to only general construction contractors of Republic of Korea.
- 4. Bidding will be carried out using a two-envelope (one is TechnicalProposal for Prequalification and the another one is Bidding documents including Price Proposal), single stage procedure as described in the Instruction to Applicants. First of all, Prequalification documents will be evaluated confidentially by the Employer and the Bid Price will be opened in the presence of the prequalified bidders who have been invited by the Employer.
