Invitation for Bids
For Construction of Modern MOPS Hospital Project
Loan No. Lao-14

1. The Government of the Lao People's Democratic Republic has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of 65,000,000 US Dollars (sixty five million US dollars) toward the cost of the "Construction of Modern MOPS Hospital Project" and intends to apply a portion of the proceeds of this loan to payments under the contract for Construction of Modern MOPS Hospital Project.
 2. The Project Executing Agency, Department of General Logistics at Ministry of Public Security now invites sealed bids from eligible bidders for the Construction of Modern Hospital for Ministry of Public Security with supplying medical equipment and HIS.
- The works to be carried out in this project comprise as follows:
- Construction of a six storied general hospital (6F/B2)
 - Supply and installation of medical equipment and HIS
 - Total number of beds: 300
 - Gross Floor Area: 24,579.13m'
 - Estimated construction period: 25 months
3. Bidding will be conducted through Competitive Bidding (CB) procedures specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible bidders that meet the following minimum qualification criteria.
 - i) A bidder, and all parties constituting the Bidder, shall have the nationality of Republic of Korea.
 - ii) For construction firms, minimum average annual construction turnover of US\$30,000,000 (thirty million US dollars) calculated as total certified payments received for contracts in progress or completed, within the last three (3) years

(2019, 2020, 2021).

- iii) For construction firms, at least one [1] general building construction projects in or outside its country of origin for the last ten [10] years from the deadline for bid submission, with a value of at least US\$ 30,000,000 [thirty million US dollars].
- iv) For construction firms, at least one [1] hospital construction (minimum GFA 25,000 m' or 300 beds) project within the last ten [10] years from the deadline for bid submission in or outside of its country of origin.
- v) For construction firms, overseas experience under construction contracts in the role of contractor for at least the last ten [10] years from the deadline for bid submission.
- vi) Financial cash flow of construction firms for a period of last three [3] months shall be more than US\$ 3,000,000 (three million US dollars).
- vii) For medical equipment firms, minimum average annual turnover of US\$12,000,000 (twelve million US dollars) calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2019, 2020, 2021).
- viii) Financial cash flow of medical equipment firms for a period of last three [3] months shall be more than US\$ 1,500,000 (one million five hundred thousand US dollars).
- ix) For medical equipment firms, at least one [1] similar medical equipment projects (minimum contract amount US\$ 2,500,000) [two and a half million US dollars] that have been successfully completed in the last ten [10] years from the deadline for bid submission in or outside of its country of origin.
- x) For HIS firms, minimum average annual turnover of US\$5,000,000 (five million US dollars) calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2019, 2020, 2021).
- xi) Financial cash flow of HIS firms for a period of last three [3] months shall be more than US\$ 500,000 (five hundred thousand US dollars).
- xii) For HIS firms, at least one [1] similar HIS projects (minimum contract amount US\$ 1,000,000 [one million US dollars] that have been successfully completed in the last ten [10] years from the deadline for bid submission in or outside of its country of origin.

- xiii) As a minimum, a bidder's three (3) years average (2019, 2020, 2021) and last year net worth (2021) calculated as the difference between total assets and total liabilities should be positive, respectively.
4. Interested eligible bidders may obtain further information from the Office of Project Management Unit and inspect the bidding documents at the address below from 9:00 to 15:00 in local time.
5. A complete set of bidding documents may be purchased by any interested bidders on the submission of a written application to the address (including e-mail) below and upon payment of a non-refundable fee of US\$300 [three hundred US dollars]. Payment can be made in cash or remitted to a bank account below. Bidding documents will be available from the 30 June 2022.
6. Both of the hardcopy and softcopy of bids must be delivered to the address and e-mail address below. The bids must be delivered to the address below along with the evidence (e.g. copy of air courier bill) that the bidder has sent out the hardcopy of bids prior to the 14:00hrs (Lao PDR time), 15 August 2022. A softcopy (scanned copy of the bids in PDF form) of bids must be sent to the e-mail address below before 14:00hrs (Lao PDR time), 15 August 2022. All bids must be accompanied by a bid security of minimum 2% of bid price. Bids will be opened and videotaped in the presence of the bidder's representatives who choose to attend or by means of videoconferencing (e.g. with Zoom) at the address below at 14:00hrs (Lao PDR time) 15 August 2022.
7. Ministry of Public Security will not be responsible for any costs or expenses incurred by bidders in connections with the preparation or delivery of bids.
8. A pre-bid meeting will take place at the following date, time and place.

 - Place: Meeting Room (2nd Fl.), Department of General Logistics, Ministry of Public Security, Lao PDR
