A bidder, and all parties constituting the bidder, shall have the nationality of the Republic of Korea.

The bid documents, including contract conditions, can be obtained beginning March 1, 2023, from the Ministry of Urban and Infrastructure, Land and Cadaster Lead Executive Office, Office No. 401, 4th Floor, New Building of the Ministry of Urban and Infrastructure, by paying a non-refundable fee of USD 1000 (ONE THOUSAND USD) or its equivalent in ETH Birr. The method of payment will be in cash, cashier's cheque, or telegraphic transfer through MUI A/C No. 1000263128374 at Commercial Bank of Ethiopia (Swift Code CBETETAA). The document will be provided in hard copy to those bidders who come in person to purchase the bidding document, and the soft copy will also be sent by email with proof of receipt to all bidders who purchased the bidding document by transfer and provide proof of payment to the email above.

- 6. Bids must be delivered to the address, before 10:00 AM. On May, 2<sup>nd</sup> /2023. Late bids will be rejected. One Original and Four Copies of the bids have to be submitted. The Technical part and Bid Security will be opened immediately after the submission deadline in the presence of bidders' representatives who choose to attend, at the address below. "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public opening.
- 7. All Bids must be accompanied by a Bid Securing Declaration/ bid security of USD 500,000.00 (FIVE HUNDRED THOUSAND USD) in a format acceptable to the purchaser. Bid submitted without prescribed Security Bond shall be liable for rejection at the time of Tender opening. Tender documents (Technical and Financial) and Security Bond shall be submitted separately.
