# Invitation for Bids

## For Construction of Modem MOPS Hospital Project Loan No. Lao-14

- 1. The Ministry of Public Security, Laos has received a Loan from the Export-Import Bank of Korea from the resources of the Economic Development Cooperation Fund (EDCF) of the Republic of Korea in the amount of USS 65,000,000 toward the cost of the Construction of Modern Hospital Ministry of Public Security and intends to apply a portion of the proceeds of this loan to payments under the contract for the Construction of Modern Hospital.
- The Project Executing Agency (PEA) now invites sealed bids from eligible bidders for the Construction of Modern Hospital for Ministry of Public Security with supplying Medical equipment and HIS.
- 3. Bidding will be conducted through Competitive Bidding (CB) procedures, single-stage and two-envelope specified in the Guideline for Procurement under EDCF Loans, and is open to all eligible bidders who have the nationality of Republic of Korea that meet the following minimum qualification criteria.

This Invitation for Bids is open to bidders only who are the combination of entities in the form of a Joint Venture or Association/Consortium (JVA), which shall cover the role of Construction, Medical equipment supply, and HIS supply under an existing agreement or with the intent to enter into such an agreement supported by a letter of intent.

#### (a) For Construction

- (i) The Bidder shall have experience under construction contracts in the role of contractor for at least the last five [5] years from the deadline for bid submission and all members who will take the role of construction must meet the requirement.
- (ii) The Bidder should have the construction projects successfully completed in the role of contractor specified below;
- at least one [1] general building (but not limited to hospital) construction projects in or outside
  its country of origin for the last ten [10] years from the deadline for bid submission, with a value of at
  least US\$ 30,000,000 [thirty million US Dollars] (at least one partner in the construction JVA must
  meet the requirement); and
- at least one [1] hospital construction (minimum GFA 25,000 m2 or 300 beds) project within the
  last ten [10] years from the deadline for bid submission in or outside of its country of origin (at least
  one partner who will take the role of construction must meet the requirement).

### (b) For Medical Equipment Supply

- (i) The Bidder shall have experience under medical equipment supplying contracts in the role of supplier for at least the last five [5] years from the deadline for bid submission and one [1] member who will take the role of medical equipment supply must meet the requirement.
- (ii) The Bidder should have the medical equipment supplying projects successfully completed in the role of supplier specified below;
- at least one [1] similar M.E. projects (minimum contract amount US\$ 2,000,000) [Two million US Dollars] (or 10% of the purchase value of medical equipment equal to: US\$ 1,627,400) that have been successfully completed in the last ten [10] years from the deadline for bid submission in or outside of its country of origin. (at least one partner in the medical equipment JVA must meet the requirement).
- In this tender document "Similar M.E. project" means the project including delivery, installation, training and warranty of medical equipment which coincides with not less than 10% of the number of the Major medical equipment to be supplied for the Project. Medical furniture and surgical instruments will not be counted. (Refer to M.E. Appendix I / article "II. Medical Equipment Item List and Quantity with Required 10% + MA + CERTI. ...... Page 152 -")

## (c) HIS Supply Company

- (i) The Bidder shall have experience under HIS supplying contracts in the role of supplier for at least the last five [5] years from the deadline for bid submission and all members who will take the role of HIS supply must meet the requirement.
- (ii) Bidder should have the HIS supplying projects successfully completed in the role of supplier specified below
- at least one [1] similar HIS projects (minimum contract amount US\$ 1,000,000) [One million US Dollars] that have been successfully completed in the last ten [10] years from the deadline for bid submission in or outside of its country of origin. (at least one partner in the HIS JVA must meet the requirement);

- In this tender document "similar HIS project" means the project including delivery, installation, training and warranty of Hospital Information System, excluding the project with a partial scope of equipment supply and/or system interface work, and 'HIS' includes OCS (Order Communication System), EMR (Electronic Medical Record) and MIS (Management Information System)
- 4. Interested eligible Bidders may obtain further information from the Ministry of Public Security, Laos and inspect the bidding documents at the address below from 09:00 to 16:00 in local time.
- 5. A complete set of bidding documents may be purchased by any interested Bidders on the submission of a written application to the address (including e-mail) below and upon payment of a non-refundable fee of US\$300. Payment can be made in cash or remitted to a bank account below. Once the application is received and the payment is confirmed, the Employers will send out the bidding document to the bidder's e-mail address stated in the application within 2 days from receipt of the payment. Bidding documents will be available from the 8 March 2023.
- 6. Both of the hardcopy and softcopy of bids must be delivered to the Address and e-mail address below according to the following conditions. The Bids must be delivered to the Address below along with the evidence (e.g. copy of air courier bill) that the Bidder has sent out the hardcopy of Bids prior to the 14:00 hrs (Lao PDR time), 11 April 2023. In addition, softcopy (scanned copy of the Bids in PDF form) of bids must be sent to the e-mail address below before 14:00 hrs (Lao PDR time)), 11 April 2023.
- 7. The Ministry of Public Security, Laos will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids. All bids must be accompanied by a bid security of minimum 2% of Bid price. The Bid Security shall be valid for twenty-eight (28) days beyond the original validity period of the bid. Late bids shall be rejected. Bids will be opened and videotaped in the presence of the Bidder's representatives who choose to attend or by means of videoconferencing (e.g. with Zoom) at the address below at 14:00 hrs (Lao PDR time)), 11 April 2023. The record including the video file shall be distributed to all Bidders regardless of their attendance.
